Cumberland Corrections: *Ashley*

- Cindy Cumberland county corrections are open; required to be at least 1 year off of probation, but felonies are OK (background check turnaround is quicker than in the past).

- SCI Camp Hill Still not allowing volunteers into the prison.

 Cumberland Co. Women- Any volunteer entering the secure side (behind bars) must be fully vaccinated. Mask and social distancing required. New volunteers must submit a volunteer application to Ashley R.

Dauphin Corrections: Rep not present – chair received report

- Mens They'll open for meetings in beginning of June for 3 days a week. Work release
 program meeting attendance has been low so they are trying to increase response and
 trying to find more days to be available. Required to have at least 1 year of sobriety OR
 go in with sponsor, masks also required. Can sign up to assist on Sobriety News online.
- Womens Starting Sept 4th weekly meetings will open. Required to wear a mask, use
 hand sanitizer, and have your temperature checked at the door, but you do not have to
 be vaccinated to attend.
- SCI Camp Hill State Prison is still not allowing AA into prisons. Perry county is opened (mentioned that perry county men's correctional facility is requesting 10 softcover Big Books, and could also use 12 & 12s)


