**Tradition Review: Tradition 12** Josh B. - "Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles above personalities."

Josh discussed how humility is a key term for this tradition, and how a modest view of
oneself helps an individual overcome roadblocks that get in the way of recovery. AA
exists because personality doesn't get in the way of our recovery principles.

**Concept 12** Ryan T. - "The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and whenever possible, substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government; that, like the Society it serves, it will always remain democratic in thought and action."

- Ryan went over Concept 12 and how it applies to every group, and that decisions be reached through group discussion. There should be no perilous power or unqualified authority positions (equality is important).


