Tradition 6 : (long form) Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to AA should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management is the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A. - medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one. This tradition is about our primary purpose and to stay humble and not worry about prestige

Concept 6

On behalf of AA as a whole, our General Service Conference has the principal responsibility for the maintenance of our world services, and it traditionally has the final decision respecting large matters of general policy and finance. But the conference also recognizes that the chief initiative and the active responsibility in most of these matters should be exercised primarily by the Trustee members of the Conference when they act among themselves as the General Service Board of Alcoholics Anonymous.

Most of the Twelve Concepts pertain to the General Service Conference, in which many decisions are made, while Concept VI itself pertains primarily to the General Service Board, which is—for lack of a better term—AA's headquarters.

Twelve Concepts identify principles by which we must live on our own terms if we wish to stay sober. The same applies to Concept VI.

The "final responsibility and ultimate authority" for AA's service activities rest with the AA groups (Concept 1), but to carry out this responsibility they must delegate to the Conference (Concept 2). The Conference, in turn, must delegate administrative authority to the General Service Board of Trustees. Board of Trustees is composed of 7 non alcoholics (A Amateurs) and 14 alcoholics (B- Boozers). The trustees have the legal and practical responsibility for the operation of AA World Services, Inc. (which embraces AA publishing as well as the General Service Office) and of the AA Grapevine, Inc. These entities have a combined cash flow of many millions of dollars annually. The trustees are also responsible for AA's public information activities. They are the guardians of the Traditions. They are responsible for carrying the AA message to other countries around the world. They are AAs bankers, overseeing the financial operations and investing AAs substantial Reserve Fund.
