- I was assigned as greeter Friday night at EPGSA between 6 and 7 and attended the main presentation- The first speaker was Hon. Kerry Myer who serves as class A trustee (non alcoholic) from MN. She is a circuit court judge presiding over a DUI court. - The main speaker was Jeff W. a past General Service Office Staff, who shared his experience how a Dr who had been informed of AA through a CPC/PI committee changed the course of his life when his father became sober in AA early in his life. To me it is a testimony, and an example of how service can and does reach the alcoholic who does not yet know there is a way out, and proof for us our work is meaningful and impactful, even though we may not directly see the results.
