

# **Archives Corner**

#### E. M. Jellinek: The Scientist Who Helped Define Alcoholism as a Disease

Elvin Morton Jellinek, born on August 15, 1890, was a pioneering researcher

who profoundly influenced how society understands alcoholism. Through his scientific work, he helped shift public perception from viewing alcoholism as a moral failing to recognizing it as a disease. His collaboration with Alcoholics Anonymous and public health advocate Marty Mann played a critical role in shaping modern approaches to addiction treatment and awareness.

In the early 20th century, alcoholism was stigmatized and poorly understood. Treatment options were minimal, and those suffering from alcohol dependence were often viewed as weak-willed or morally flawed. Jellinek changed that narrative. After joining the Yale Center of Alcohol Studies in the 1940s, he began conducting rigorous research into patterns of alcohol use and dependence. It was during this time that he became aware of the growing movement of

Alcoholics Anonymous, founded in 1935 by Bill Wilson and Dr. Bob Smith.

Jellinek saw value in the personal recovery stories emerging from AA. In 1946, he conducted a groundbreaking study using self-reported data from ninety-eight members. From this research, he developed what became known as the "Jellinek Curve," a visual representation of the progressive stages of alcoholism, from initial use and increasing dependency, through physical and emotional deterioration, and eventually into recovery. This curve mirrored the experiences described by AA members and gave a scientific structure to their stories.

In 1960, Jellinek published his most influential work, *The Disease Concept of Alcoholism*. In this book, he classified alcoholism into several types, including the well-known Gamma alcoholism, which involved physical depend-

ence, loss of control, and a progressive course. He argued that this form met

the criteria of a disease. This concept aligned closely with the way AA members described their experience, particularly the idea of powerlessness over alcohol and the need for a sustained recovery process.

A key ally in promoting this new understanding was Marty Mann, the first woman to achieve long-term sobriety in AA and a passionate public health advocate. Mann founded the National Committee for Education on Alcoholism in 1944, the first national organization to promote the disease model of alcoholism. She and Jellinek worked in parallel and often in collaboration to bring credibility to the cause. Mann used Jellinek's scientific findings to educate the public, employers, and policymakers, while Jellinek's research benefited from Mann's outreach and advocacy.

Their combined efforts led to lasting changes in how alcoholism was treated in the United States. The American Medical Association eventually adopted the disease model, insurance companies began covering treatment, and public health campaigns started focusing on education and prevention rather than punishment.

E. M. Jellinek passed away in 1963, but his legacy endures. Through collaboration with AA and advocates like Marty Mann, he helped define alcoholism as a complex, treatable medical condition. His work continues to influence addiction science, public health policy, and recovery communities around the world.

"Reminding ourselves that we have decided to go to any lengths to find a spiritual experience, we ask that we be given strength and direction to do the right thing, no matter what the personal consequences may be." —Alcoholics Anonymous, p. 79

In our drinking histories, we have unbelievable wreckage to the point that most of us don't believe we could ever undo the damage. Even the thought of cleaning up our lives' mess caused us to be anxious and overwhelmed.

We knew we should make things right, but most of us gave up long before we got to the program. Then we come into the program and get sober, and at every meeting, we read the Twelve Steps, including the amends Steps Eight and Nine.

I recall shuddering at this possibility, but I compartmentalized it as something to take care of way off in the future, if at all. However, something amazing transpires as we begin to take the steps. The "impossibles" in life become "possibles." My sponsor had me categorize my Eighth Step into now, soon, and never.

Once I did the "now's," the "soon's" moved to the forefront. Surprisingly, once I did the "soon's," the "never's," the ones with significant personal consequence, didn't seem as daunting. It was my experience that the harder the amend, the better the outcome, and it usually ended up as some sort of spiritual experience. Our book tells us that we can't shirk our responsibilities, even if it results in personal consequences.

It's important to note that each situation is different, and in the spirit of never hurting another, amends should be discussed with a sponsor before they are completed. I am so glad I was able to make those amends to people I had harmed, but it would not have been nearly as thorough without the program closing that "personal consequence" loophole that my subconscious would have used to avoid cleaning up the damage I inflicted on others.

#### Greetings GSR's,

There will be open sharing to get feedback from the GSRs/Groups on two questions related to the Founder's Literature. Please share this information with your homegroups in District 36 11/15/2025 8:45am -11:20am.

#### Background

- At the 75th General Service Conference, there were two agenda items related to adding additional protections to the Founders' Literature. (One was to require a 3/4 vote threshold, and the other was to change the Conference Charter).
- These items were on the agenda for two different Conference committees, both took "no action", and both had an additional consideration that basically said we need to define what is categorized as the co-founders' writings, before considering additional protections for the Founders' Literature.
- Report and Charter made a related recommendation that received substantial unanimity and became an advisory action:

The committee recommended that the General Service Board classify all AAWS and AA Grapevine literature written prior to 1971 as Recovery, Service, or Archival/Historical; review existing policies and consider proposing additional policies as appropriate for updating each classification, and that a progress report be provided to the 2026 General Service Conference.

#### What Dan is asking as Feedback for EPGSA

• Although we have an advisory action to categorize literature, at this time there are no details about the process, how it will proceed, etc., but I do expect something will be presented at the 2026 General Service Conference. To help me be better prepared, I'd

like the groups to discuss these two questions, and have the GSRs provide a summary of their group's conscience at the EPGSA Convention:

- 1. What general process should we use to classify writings as Recovery, Service, or Archival/Historical? Who should determine the classification
- 2. What literature do you consider to be in each category of Recovery, Service, or Archival/Historical?
- These two questions are not proposed agenda items, and Delegates have not been asked to solicit feedback on them. They are for me alone, so that I can get a sense of the groups' thoughts on the issue, which will ultimately help inform me better for the 2026 Conference.
- Groups are not being asked to take a formal vote on the questions, but rather to just discuss them, in whatever manner they wish. The idea is to spark a really good and thoughtful consideration of the issue. If other ideas come up beyond the two questions, please share them!
- This feedback is about the advisory action only. Although issues such as whether we should make future changes to Bill's writings, or if we need further literature protections, etc. are very important, these items are outside the scope of the advisory action and the sharing I'd like to receive.

Again, I strongly encourage you to get this out to the GSRs and groups in your District, and to come to the EPGSA Convention with lots of great feedback to share - I'm really looking forward to hearing the groups' thoughts!
