Intergroup Website Judy W.	Jose gave report: by-laws are now on HAI website *Proposed HAI Event Submission Language: In adherence to the 5th and 6th traditions, we generally post only AA events. The criteria in place for an intergroup to post an event is that it be put on by AA's, for AA's and about AA. For HAI purposes, if all the answers to the following 3 questions are yes, then the event will be posted. 1) Does the event host identify as an AA Group or share the same primary purpose: To stay sober and help other alcoholics to achieve sobriety? 2) Does the event refrain from affiliating HAI with any outside facility or enterprise? 3) Is the meeting or even open to all alcoholics? If the answer is no, the host may request an exemption, which involved bringing the event flyer to the next HAI meeting for a group conscience vote and if it passes, displaying the following disclaimer: HAI's primary purpose is to help ALL alcoholics achieve sobriety and help others stay sober. Our event posting policy is based on the AA 5th and 6th Traditions. This post does not imply HAI endorsement or affiliation with the host, and if this event targets an AA group subpopulation, hosts are urged to NOT turn away the still sick and suffering alcoholic in need of help, regardless of demographic.
