Monthly Tradition 6: (Long Form) - Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals, which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A. — and medically supervised. While an A.A. group may

cooperate with anyone, such cooperation ought never to go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one. (Eric L.)

Times were tough and this showed in the low attendance	Growth of Area 59 and the Formation of Its Districts The emergence of the 48 districts, including the linguistic district, that now represent Eastern Pennsylvania Area 59 began in 1954. Initially districts were referred to as “Areas.” In 1954, election results identified six geographical “Areas”: two in Philadelphia, plus Lehigh Valley, Scranton, Williamsport, and Reading.

of the First Annual State Convention in 1958. In 1977 the 12 areas became known as "Districts"

As the years progressed....

...We presently have a grand total of 48 districts.

The 1965 Convention program shows 12 "Areas," and by 1977, these "Areas" became known as districts. At that time, districts were numbered: 1–5; 6A; 6B; 7–9; 10A; 10B; 11-12, for a total of 14.

Between 1978-1981, due to rapid growth in the number of groups, additional districts were created, or existing districts split. This included Districts 1B and 12B in 1978, Districts 2B, 6C, and 11B in 1979, Districts 8B and 11C at the end of 1980. By June of 1981, Districts 9A and 4B were formed, bringing the total to 23 districts.

Between June and September of 1981, the districts were renumbered, from 21 through 43. No archival information has been found explaining why this numbering system was adopted. It may have been intended to avoid confusion between "old" and "new" district numbers or to accommodate early computer systems that may not have recognized certain formats; however, no documentation confirms either explanation.

By the end of 1981, Districts 44, 45, 46, and 47 had been formed, resulting in 27 districts in Area 59. From 1982 to 1991, 10 additional districts (48 through 57) were established through splits and reorganization. By the end of 1992 the Area had grown to 45 districts (adding 58–65). The last recorded district division occurred in 1997 with the formation of Districts 66 and 67.

In 2008 District 68 was established, a "boundary-less" linguistic district formed to ensure adequate representation of the Spanish-speaking population.

Motion to have all current DCMs and area officers submit a written service resume prior to EPGSA for voters to reference during Area elections.

Background Information:

I am making this motion after speaking with several people about the voting process at EPGSA and discussing ways to make it more informative for GSRs during elections. The motion was brought up at our last district meeting. Only one GSR in attendance had previously attended EPGSA during a voting year. We did not take a formal vote, however, the discussion that ensued supported having something more in place to make informed decisions during our elections.

When I served as a GSR, I often had little to no knowledge of the individuals standing for Area Panel positions. In many cases, I either asked others who they were voting for or selected a name at random, especially if that person appeared to be leading. I know I am not the only person who has experienced this.

As a DCM, I encourage GSRs to attend Area events so they can become familiar with trusted servants and learn more about the people involved in service. However, the reality is that attendance at these events is often limited. During elections, the voting body is frequently provided with little more than the names of those standing for positions. This does not give GSRs enough information to make fully informed decisions and is not the most effective way to elect trusted servants to the Area Panel.

I have reached out to several Areas regarding their election procedures, and this is what I have found:

The following Areas require candidates to give a verbal service resume when standing for a position:

Areas 11, 12, 15, 30, 44, 45, 49, 60

There is currently a motion pending in Area 15 to post service resumes on their website during elections. They are voting on the motion at their next area meeting. It is the only Area I have reached out to that may potentially present a written service resume for the body to reference prior to or during elections.

I have not yet reached out to, or heard back from, additional Areas, but I am continuing to gather information on how other Areas facilitate their elections.

Due to the length of our election process, I believe that pre-submitted service resumes may be more beneficial and time-efficient than having individuals give verbal resumes during elections.
